STAIR IS AN AFTER SCHOOL PROGRAM USING AROUND 350 VOLUNTEER TUTORS, WHO TEACH ONE-ON-ONE READING LESSONS TO AT-RISK CHILDREN. CHILDREN ARE CHOSEN BY THEIR TEACHERS IN THE 2016-2017 TAX YEAR. THERE WERE 11 SITES THROUGHOUT BIRMINGHAM THAT SERVED OVER 170 STUDENTS. STUDENTS MET TUTORS TWICE PER WEEK FOR TWO HOURS DURING SEPTEMBER THROUGH APRIL. STUDENTS ARE TAUGHT A VARIETY OF SKILLS NECESSARY TO READ AT GRADE LEVEL. THE EFFECTIVENESS OF THE PROGRAM IS MEASURED BY THE STANDARDIZED TEST GIVEN BY THE SCHOOL. STUDENTS WHO COMPLETED THE STAIR PROGRAM CONSISTENTLY SHOW AN AVERAGE RATE OF IMPROVEMENT OVER 90% IN READING FLUENCY.
