STAIR IS AN AFTER SCHOOL PROGRAM USING AROUND 486 VOLUNTEER TUTORS, WHO TEACH ONE-ON-ONE READING LESSONS TO AT-RISK CHILDREN. CHILDREN ARE CHOSEN BY THEIR TEACHERS IN THE CURRENT TAX YEAR. THERE WERE 13 SITES THROUGHOUT BIRMINGHAM THAT SERVED OVER 215 STUDENTS. STUDENTS MET TUTORS TWICE PER WEEK FOR TWO HOURS DURING SEPTEMBER THROUGH APRIL. STUDENTS ARE TAUGHT A VARIETY OF SKILLS NECESSARY TO READ AT GRADE LEVEL. THE EFFECTIVENESS OF THE PROGRAM IS MEASURED BY THE STANDARDIZED TEST GIVEN BY THE SCHOOL.
